PLEASE TAKE NOTICE that on , 2002 at 2022 at 2013 or as soon thereafter as counsel may be heard in Department F of the above-entitled Court, located at 12720 Norwalk Blvd. Norwalk, CA 90650, non-party press organization Knock LA and non-party government watchdog group First Amendment Coalition (collectively, the "Media Coalition") will and hereby do seek a court order to unseal the court records related to Search Warrant No. NW20500854 issued for personal property, including but not limited to 17 cell phones and two digital cameras, seized from 17 individuals on September 8, 2020, near the intersection of Normandie Avenue and 110th Street in the County of Los Angeles. The Los Angeles Sheriff's Department executed the Search Warrant as part of its investigation of individuals exercising their First Amendment right to free speech, peacefully protest, and film deputies. No charges have been brought against any of these arrestees two years after their cell phones were seized and searched.

The Media Coalition asks the Court to unseal the Search Warrant, as well as any related court documents under seal, including but not limited to any applications and supporting affidavits, returns, motions or orders related to sealing the warrant, lists of the inventory seized during the search, and any motions or orders related to the admission or suppression of items seized pursuant to the warrant ("Search Warrant Records")

This Request is made on the following independent grounds. *First*, pursuant to the express provisions of Penal Code § 1534(a), these executed and returned Search Warrant Records "shall be open to the public as a judicial record." Penal Code § 1534(a) (emphasis added).

Second, these search warrant documents filed with the court are presumptively open to the public and press under the First Amendment to the United States Constitution, Article I, § 2(a) and Article 3, § 1 of the California Constitution; California Penal Code § 1534(a); California Rule of Court 2.550(c); and the common law and may not be sealed absent specific, on-the-record findings establishing an overriding interest that overcomes the right of public access to the records.

On December 14, 2021, this Court issued a minute order keeping the Search Warrant Records under seal, but failed to state that it "expressly finds facts that establish that ... there exists an overriding interest that overcomes the right of public access" to these court records and failed to cite the four other parts of the five-part sealing test, as required by the First Amendment and Rule of Court 2.550(d).

The Sheriff's Department cannot satisfy the rigorous requirements to justify the continued sealing of these court records. The Sheriff's Department has contended in the past that the Search Warrant Records should remain under seal to protect an ongoing criminal investigation of the

protesters. But nearly two years have passed since search of the cell phones and cameras, yet prosecutors have not brought a single charge against the arrestees. This is likely because the sheriff's department lacked probable cause to obtain this search warrant in the first place and possibly conducted the arrests, seizure, and searches to chill the First Amendment rights of the arrestees.

The Media Coalition therefore respectfully requests the Court to issue an order to unseal all Search Warrant Records.

This request is based upon the attached Memorandum of Points and Authorities, Declaration of Susan E. Seager with Exhibits A-C, and on all pleadings, records, and files in this action, on all matters of which judicial notice may be taken, and on argument and evidence presented at the hearing on this Request filed by the Media Coalition.

MEMORANDUM OF POINTS AND AUTHORITIES Summary of Argument

The Los Angeles Sheriff's Department has declared war on the First Amendment. Sheriff Alex Villanueva unsuccessfully pushed for the prosecution of National Public Radio affiliate reporter Josie Huang for filming police in 2020¹ and announced earlier this year a criminal investigation of *Los Angeles Times* reporter Alene Tchekmedyian for reporting that Villanueva covered up deputy misconduct.²

In this case, the Sheriff's Department chased down and arrested 17 fleeing individuals who were exercising their First Amendment right to protest and film deputies on September 8, 2020, then obtained a search warrant the next day based on questionable grounds to search their cell phones and digital cameras. It has been nearly two years since this Court signed that warrant -- Search Warrant NW20500854 -- on September 9, 2020 and allowed deputies to pry into deeply personal aspects of these people's lives via their cell phones and cameras. Yet no charges have been filed and the search warrant records filed with this Court remain sealed. It is time to unseal these court records to shine a spotlight on whether the Sheriff's Department used the arrests and search warrant to punish individuals for exercising their First Amendment rights on September 8, 2020 without probable cause for all 17 arrestees.

Penal Code §1534(a) expressly states that after a search warrant has been executed and returned, all "documents and records of the court relating to the warrant *shall* be open to the public as a judicial record." Penal Code § 1543(a) (emphasis added). The First Amendment to the United States Constitution; Article I, § 2(a) and Article 3, § 1 of the California Constitution; California Rule of Court 2.550(c); and common law all provide that court records are presumptively open. These constitutional and common law provisions and Rule 2.550(d) require this Court to issue a *public* court order to justify any sealing based on *specific factual* findings.

Despite these mandates, this Court issued a brief sealing order on December 14, 2021 without making on-the-record factual findings or following the five-part test required for sealing court records required by the First Amendment, Rule of Court 2.550(d), and common law. Because

this Court's sealing order did not satisfy the First Amendment, Rule 2.550(d), or common law, and because the Sheriff's Department cannot satisfy the rigorous requirements to justify continued secrecy of these court records two years after the arrests and searches were executed, the Media Coalition respectfully requests this Court to immediately unseal all court records related to Search Warrant No. NW20500854 ("Search Warrant Records").³

Statement of Facts

On September 8, 2020, the Los Angeles Sheriff's Department chased and arrested 17 people after a street protest for Dijon Kizzee, a young black bicyclist fatally shot by deputies. Exhibit A, p. 55. All 17 individuals were arrested on a misdemeanor charge of failure to disperse. *Id.* The Sheriff's Department seized 17 cell phones and two digital cameras seized from the 17 arrestees. *Id.*, pp. 28-29, 52-54. Today, nearly two years later, none of the individuals has been charged. Exhibit B, p. 69.

There's a good chance that no charges will be brought because of a lack of evidence of criminal acts by the arrestees. For example, the Sheriff's Department has claimed that one arrestee, Hugo Padilla, was arrested because he became "violent." But his live September 8, 2020 video on YouTube shows he was riding his bike outside of the protest and was suddenly knocked down and arrested by a deputy in the middle of an empty street several blocks from the protest. *See*Normandie and Imperial hwy los angeles protest at sheriff station blm dijon keezee - YouTube

(Padilla's arrest can be seen at 36:02). The Sheriff's Department filmed its own videos of the events of that night, but has refused to provide those videos to the public to show supposed "violence."

Deputies mostly seized mundane gear like a skateboard, bike, flashlights, helmets, and antipolice signs. Exhibit A, p. 32. Only one protester, Jeremy Smith, was allegedly carrying smoke bombs, which deputies said was evidence of a plan to riot. *Id.*, p.31. But deputies claimed they "mixed up" the cell phones "during the booking process" and "were unable to link any of the cell

phones to any of the suspects arrested." Id., p. 56. Despite lacking individualized probable cause of criminal acts by each of the 17 arrestees, the Sheriff's Department obtained a search warrant, apparently to search all 17 cell phones and two digital cameras. Exhibit B.

On November 1, 2021, two of the arrestees, Padilla and Christina Astorga, filed a motion to in this Court to unseal the Search Warrant Records for public viewing. Exhibit B, p.69. On December 14, 2021, this Court held a closed-door hearing with only representatives for the Sheriff's Department. *Id.*, p. 70. After the closed-door hearing, the Court issued a minute order declining to unseal the Search Warrant records for the public. *Id.* The Court's minute order did not list the factual or legal basis for keeping the records sealed from the general public, nor did it follow the five-part test to justify sealing, as required by the First Amendment and Rule of Court 2.550(d). *Id.* This Court ordered the Search Warrant records unsealed solely for a U.S. District Court presiding over a civil rights case arising from the September 8, 2020 events, *Astorga v. County of Los Angeles. Id.* This Court asked the federal court to decide whether this Court could unseal or redact its own superior court records. *Id.*

Once before the federal court, the issue was narrowed to a simple discovery dispute. On January 7, 2022, a federal magistrate judge ordered the Sheriff's Department to turn over 29 pages from the Search Warrant Records to Padilla and Astorga as part of discovery in *Astorga v. County of Los Angeles*, and allowed the Sheriff's Department to designate the records as non-public records under the federal court's protective order. Exhibit C, p. 73. The magistrate judge did not decide Astorga and Padilla's broader motion to unseal the Search Warrant Records to the public. *Id.* As of today, this Court's December 14, 2021 blanket order sealing its own records remains in place. It is not governed by the federal magistrate judge's order governing discovery records.

A. Penal Code § 1534(a) Requires These Search Warrant Records To Be Unsealed

California Penal Code § 1534(a) provides that after a search warrant is executed and returned to the court, all "documents and records of the court relating to the [search] warrant ... shall be open to the public as a judicial record." Cal. Penal Code § 1534(a) (emphasis added). The California Legislature did not impose any qualifications or limitations upon this right of access to Search Warrant Records, other than the passage of time. In PSC Geothermal Services Co. v. Superior Court, 25 Cal. App. 4th 1697 (1994), the Court of Appeal explained that the California Legislature did not provide for any exceptions to Penal Code Section 1534's mandate that materials associated with a search warrant are public documents, noting that "[t]here is no exception in the statute for instances ... [even] where the search is used to further an ongoing investigation." Id. at

1713 (emphasis added). California courts have recognized only one exception to this rule: where sealing of search warrant materials is necessary to protect the identity of a confidential informant, which is not apparently at issue here, but even if it were, the only portions that may be withheld are those that "would effectively reveal the identity of an informant." *See People v. Hobbs*, 7 Cal. 4th 948, 971 962–63 (1994). The remainder must be disclosed.

Based on the mandate of Penal Code § 1534(a), the public is entitled to immediate access to the Search Warrant, the supporting affidavits, and returns that have been filed with the Court in this case. The plain language of Penal Code § 1534(a) is sufficient to resolve this case and require immediate public disclosure without further analysis.

B. The First Amendment and Rule 2.550 Require These Records To Be Unsealed

1. The First Amendment Creates a Presumptive Right of Public and Press Access to Court Criminal Records, Including Search Warrant Records

The First Amendment and Rule 2.550 provide an independent presumptive right of access to these court records and require this Court is issue an on-the-record order citing specific facts and follow a five-part test for sealing.

This right of access to criminal court records has its roots in the United States Supreme Court's long-standing recognition that the public and press have a presumptive First Amendment right of access to a variety of criminal proceedings, from pre-trial hearings to trials. *Richmond Newspapers, Inc. v. Virginia*, 448 U.S. 555, 580 (1980) (criminal trials); *Press-Enterprise Co. v. Superior Court*, 464 U.S. 501, 505-508 (1984) ("*Press-Enterprise I*") (voir dire); *Waller v. Georgia*, 467 U.S. 39, 47 (suppression hearing); *Press-Enterprise Co. v. Superior Court*, 478 U.S. 1, 12-13 (1986) ("*Press-Enterprise II*") (preliminary hearings).

Federal circuit courts have held that the presumptive First Amendment right of access to criminal court proceedings applies equally to criminal court records. As then-Ninth Circuit Judge Anthony Kennedy stated in CBS, Inc. v. District Court, 765 F.2d 823 (9th Cir. 1985), the First Amendment creates a "presumption that the public and the press have a right of access to criminal proceedings and the documents filed therein," which "extends to documents filed in pretrial proceedings as well as in the trial itself." Id. at 825. Similarly, in Associated Press v. District Court, 705 F.2d 1143, 1147 (9th Cir. 1993), the Ninth Circuit held that "the First Amendment right of access to criminal proceedings applies, in general, to pretrial documents [.]"

The Eighth Circuit has held that the First Amendment right of access applies to search warrant affidavits filed in court because, "even though a search warrant is not part of a criminal

trial itself, like voir dire, a search warrant is certainly an integral part of a criminal prosecution," and is often "at the center of pre-trial suppression hearings." *In re Search Warrant for Secretarial Area Outside Office of Thomas Gunn*, 855 F.2d 569, 573 (8th Cir. 1988).

In 1999, the California Supreme Court held in *NBC Subsidiary (KNBC-TV), Inc. v. Superior Court*, 20 Cal. 4th 1178 (1999) that the public and press have a First Amendment right of access to both judicial proceedings and records. The Court's sweeping, unanimous decision cited with approval numerous decisions upholding a First Amendment "presumption of access ... [for any] *documents or records* of ... [judicial] proceedings [that] are *filed with the* court[.]" *Id.* at 1208 & n.25 (emphasis added).

The Media Coalition was not a party to the motion to unseal when this Court issued December 14, 2021 sealing order and not estopped from challenging the sealing order. *Wilson v. Science Applications Internat. Corp.*, 52 Cal.App.4th 1025, 1028. (1997) (members of public may challenge sealing order if not parties to prior sealing proceeding). "[P]rior sealing orders" are not permanent; they are not "a juridical black hole from which no light can ever escape." *In re Marriage of Nicholas*, 186 Cal. App. 4th 1566, 1569 (2010). A court has jurisdiction to revisit prior sealing orders because a court has "custody and control over its own files," "[s]ealing orders, by their nature, turn on particular circumstances, which may change or evolve over time," and "well-established constitutional, case, and statutory authority subjects sealing orders to continuing review and modification by the trial judge who sits in the same judicial proceeding." *Id. See also id.* at 1568 (holding that family law judge had jurisdiction to revisit a sealing order entered by previous judge in same case based on the *NBC Subsidiary*'s rule that court records are presumptively open to the public and press).

2. All the Public Benefits of Openness Apply to these Search Warrant Records

One of the fundamental interests vindicated by the First Amendment right of access to courts is "a first principle that people have the right to know what is done in their courts." Wilson, 52 Cal. App. 4th at 1030 (citing Estate of Hearst, 67 Cal. App. 3d at 782-784); see also id. ["[T]raditional Anglo-American jurisprudence distrusts secrecy in judicial proceedings and favors a policy of maximum public access to proceedings and records of judicial tribunals [I]t is a vital function of the press to subject the judicial process to 'extensive public scrutiny and criticism.'") (citing Shephard v. Maxwell, 384 U.S. 333, 350 (1966)).

As the United States Supreme Court noted in *Richmond Newspapers, Inc. v. Virginia*, 448 U.S. 501, 572 (1980), "[p]eople in an open society do not demand infallibility from their institutions, but

it is difficult for them to accept what they are prohibited from observing." Open court proceedings, the Court repeatedly has pointed out, "gives assurance that established procedures are being followed and that deviations will become known"; it thus enhances "both the basic fairness" of the proceeding, "and the appearance of fairness so essential to public confidence in the system." *Press-Enterprise I*, 464 U.S. at 508.

Here, the public has a heightened interest in these records. Sheriff Villanueva is running for reelection this year and the election is a little more than two months away. Because of numerous allegations of misconduct against the sheriff made by a variety of individuals and groups, the County Board of Supervisors has put a charter amendment on the ballot that would allow the Board to remove a sheriff from office for serious misconduct. The sheriff has lashed out at anyone who dares to question his leadership or report about his or his department's actions. His department has arrested and launched criminal investigations of reporters, street videographers, and protesters exercising their First Amendment rights. It is especially important to permit public scrutiny of the Sheriff's Department's unusual procedure of seizing and searching 17 cell phones and two cameras of 17 people who were arrested and never charged, especially when the Sheriff's Department lacked any individualized probable cause for each protester's cell phone.

3. These Court Records May Not be Sealed Without a Public Sealing Order Citing Facts and Meeting the Five-Part Test for Sealing

The First Amendment right of access to court records cannot be canceled by a secret court order lacking factual and legal findings. To the contrary, any sealing order must be placed in the public record and "specific, on-the-record findings" must be "made" by the court. Press-Enterprise II, 478 U.S. at 13. The Supreme Court has outlined a strict test for a government agency seeking to seal court proceedings: "Where . . . the State attempts to deny the right of access in order to inhibit the disclosure of sensitive information, it must be shown that the denial is necessitated by a compelling governmental interest, and is narrowly tailored to serve that interest." Press-Enterprise I, 464 U. S. at 510 (quoting Globe Newspaper Co. v. Superior Court, 457 U. S. 596, 606-607 (1982). "The presumption of openness may be overcome only by an overriding interest based on findings that closure is essential to preserve higher values, and is narrowly tailored to serve that interest. The interest is to be articulated along with findings specific enough that a reviewing court can determine whether the closure order was properly entered." Id. (quoting Globe Newspaper, 457 U.S. at 606-607.)

Relying on *Press-Enterprise I*, the California Supreme Court adopted the same test for sealing court proceedings and records: "[B]efore substantive courtroom proceedings are closed or transcripts are ordered sealed, a trial court must hold a hearing and expressly find that (i) there exists an overriding interest supporting closure and/or sealing; (ii) there is a substantial probability that the interest will be prejudiced absent closure and/or sealing; (iii) the proposed closure and/or sealing is narrowly tailored to serve the overriding interest; and (iv) there is no less restrictive means of achieving the overriding interest." *NBC Subsidiary*, 20 Cal. 4th at 1217-1218.

This strict test for sealing means that "the court may not base its decision on conclusory assertions alone, but must make specific factual findings." Washington Post v. Soussoudis, 807 383 F.2d 383, 392-93 & n.9 (4th Cir. 1986). In Oregonian Publ. Co. v. District Court, 920 F.2d 1462 (1990), the Court of Appeals for the Ninth Circuit vacated the trial court's order sealing a court record because the order was "not supported by any factual finding" and because the court provided "no evidentiary support" for its conclusions. Id. at 1467. The court found the defendant's motion to seal the court record -- his plea agreement -- equally defective because the motion did "not present facts." Id.

California codified this presumptive First Amendment right of access to court records in civil and criminal court proceedings in California Rules of Court 2.550. See Savaglio v. Wal-Mart Stores, 149 Cal. App. 4th 588, 597; see also Rule of Court 2.550 Advisory Committee Comment (the standard for sealing a document under the rule "is based on NBC Subsidiary These rules apply to civil and criminal cases."). Rule 2.550(c) provides that "[u]nless confidentiality is required by law, court records are presumed to be open." A court "record" is defined broadly as "all or a portion of any document, paper, exhibit, transcript, or other thing filed or lodged with the court, by electronic means or otherwise." Cal. R. Ct. 2.550(b)(1) (emphasis added).

California Rule of Court 2.550(d) provides that a court record may not be sealed absent a finding that: (1) an overriding interest supports sealing; (2) a substantial probability exists that the interest will be prejudiced absent sealing; (3) the sealing is narrowly tailored to serve the overriding interest; and (4) no less restrictive means exist to achieve the identified overriding interest. Cal. Rule of Ct. 2.550(d); see also NBC Subsidiary, 20 Cal. 4th at 1218-19.

Because the Search Warrants and the materials related to them were filed in this Court, the Search Warrant Records are court records just like any other and subject to a presumptive right of public and press access under the First Amendment and Rule 2.550(c). These court records may only be sealed if this Court issues a public order that satisfies the First Amendment and Rule

2.550(d). California Rule of Court 2.550(d) bars a court from sealing court records unless the court issues a public order finding that: (1) an overriding interest supports sealing; (2) a substantial probability exists that the interest will be prejudiced absent sealing; (3) the sealing is narrowly tailored to serve the overriding interest; and (4) no less restrictive means exist to achieve the identified overriding interest. Rule of Ct. 2.550(d); see also NBC Subsidiary, 20 Cal. 4th at 1218-19.

This Court's December 14, 2021 order did not meet these requirements. The Court made no on-the-record factual findings and its sealing order is not narrowly tailored – it is a blanket order sealing all Search Warrant Records. The sealing order therefore violates the First Amendment and Rule of Court 2.550(d) and is invalid.

4. The Sheriff's Department Cannot Show a Valid Basis for Keeping the Search Warrant Records Sealed Two Years After Execution With No Charges

The Sheriff's Department cannot meet its burden of presenting evidence that would allow this Court to "expressly find[] facts that establish that ... there exists an overriding interest that overcomes the right of public access" to these court records" or satisfy the four other parts of the sealing test required by the First Amendment and Rule of Court 2.550(d).

Whatever interest claimed by the Sheriff's Department to keep these Search Warrant documents secret falls far short of overcoming the public right of access to these court records. The blanket sealing order is not narrowly tailored, as required by Rule 2.550.

It has been two years since the arrest and seizure of the cell phones and digital memory cards of the 17 people who were arrested. Not a single charge has been filed. It is unlikely that a criminal investigation into conspiracy to riot and conspiracy to assault a police officer remains ongoing or important enough to justify secrecy 24 months after the search.

C. The Common Law Creates an Independent Right Of Access to These Records

More than 40 years ago, the United States Supreme Court recognized that there is a common law right to "inspect and copy public records and documents, including judicial records and documents." *Nixon v. Warner Communications*, 435 U.S. 589, 597 (1978). The Court indicated that this right includes a presumption "favor of public access to judicial records." *Id.* at p. 602. This common law right of access is older than the First Amendment itself. "The existence of this [common law] right, which antedates the Constitution and which is applicable in both criminal and civil cases, is now 'beyond dispute." *Leucadia, Inc. v. Applied Extrusion Technologies, Inc.*, 998 F.2d 157, 161 (3d Cir. 1993) (citation omitted).

California courts have long recognized that California's common law creates a presumptive right of access to court proceedings and court records. "(C)ourt records are public records open to inspection." Copley Press, Inc. v. Superior Court, 6 Cal. App. 4th 106, 108, 117 (1992) ("Copley II"). "[P]reclusion from public inspection should be permitted only upon a showing that revelation would 'tend to undermine individual security, personal liberty, or private property, or ... injure the public or the public good." Id. (citing Estate of Hearst, 67 Cal. App. 3d at 782-83). See also Craemer v. Superior Court (1968) 265 Cal. App. 2d 216, 216 n.3 (1986) ("The right of a citizen to inspect public writings has its origin in the common law."); McGuire v. Superior Court, 12 Cal. App. 4th 1685, 1687 (1993). Courts in other jurisdictions have recognized a common law right to search warrant records filed with the court. See, e.g., In the Matter of 2 Sealed Search Warrants, 710 A2d 202, 210-11 (Super. Del. 1997).

Under the common law, sealing orders can be justified only in "exceptional" circumstances where sealing is necessary to promote a "compelling" interest. *Estate of Hearst*, 67 Cal. App. 3d at 785. Because no exceptional circumstances exist here, these Search Warrant Records must be unsealed immediately under the common law.

D. A Federal Court's Protective Order in Another Case Has No Bearing on This Court's Obligation to Unseal Its Own Records Under the First Amendment

The fact that a federal court issued a routine discovery order in *Astorga v. County of Los Angeles* directing the Sheriff's Department to produce 29 pages of the Search Warrant Records to the plaintiffs and that the Sheriff's Department designated those pages as non-public documents has no bearing on the Media Coalition's motion to unseal the Search Warrant Records in this Court. The Media Coalition is not a party to the *Astorga* case and not bound by any orders in that case. Nor is this Court bound by discovery orders in federal court. This Court has "custody and control over its own files." *In re Marriage of Nicholas*, 186 Cal. App. 4th at 1569. *See generally Mid-Atlantic Recycling Technologies, Inc. v. City of Vineland* (D. N.J. 2004), 222 F.R.D. 81, 86 ("[T]he Federal Rules of Civil Procedure do not act as an automatic bar of a litigant's rights to obtain or seek documents" from a state agency under state law.) The First Amendment, common law, and Rule of Court 2.550(d) require this Court to decide this motion to unseal its own records.

Conclusion

The public interest in opening these search warrant records is very high. There is no "overriding" interest that justifies keeping these records secret two years after the search warrant was issued. Because there is no interest here that can overcome the strong presumption of public

On 09-08-20, there was a scheduled protest at South Los Angeles Sheriff Station (1310 W Imperial Highway, Los Angeles, 90044) in regard to the recent death of "Dijon Kizzee." This protest was scheduled to start at 1600 hours and was advertised through many social media platforms (Instagram, Facebook, Twitter, Etc.).

It should be noted, this protest followed a protest which took place on 09-07-20 which eventually was declared an unlawful assembly, making this the fourth consecutive day of protest. While keeping the peace and observing the protest, numerous residents from within the community were involved in an argument against the protesters shouting for them to leave because they are creating a hostile environment within the community.

During the course of this protest, numerous protesters occupied Imperial Highway between Normandie Avenue and 108th Street, blocking traffic and creating a hostile and unsafe environment for the surrounding public. The protesters armed themselves with the following types of riot gear:

- shields containing hard surfaces, padding and straps on the interior for a supportive grip
- shoulder pads, shin guards, knee pads, gloves and chest and spine protectors
- plastic body armor
- helmets
- wooden sticks and metal poles (See photographs).
- smoke bombs, spray cans and empty beer bottles
- flashlights, gloves, goggles and first aid kits. We additionally observed tourniquets and trauma wound dressing.

Although the planned protest was scheduled to be "peaceful" numerous protesters began throwing items towards Deputies including fireworks, smoke bombs, frozen water bottles and sealed aluminum canned foods.

At approximately 2010 hours, the Los Angeles County Sheriff Department Sergeant Muller #244802, declared the protest an unlawful assembly. Numerous dispersal orders were given to the protesters over a loud PA speaker to immediately disperse. Most of the protesters peacefully left the surrounding location. The following protestors failed to leave the immediate area and were subsequently arrested on 112th Street between Budlong Avenue and Normandie Avenue:

S/White, S/Eleveld, S/Fitzpatrick, S/Wolfgang, S/Chakravarti, S/Marsella, S/Manos, S/Padilla, S/Knox, S/Unzuelta, S/Astorga, S/McQueen, S/Gannon, S/Sanders, S/Chow, S/Lanahan, and S/Lacoste.

We additionally recovered numerous canister style pull pin "smoke grenades" typically used as a obscuring device for undetected attack (see photographs). These "smoke grenades" were taken from S/White's person during a search incident to arrest. Arson and Explosives Sergeant, Sergeant Hansen #290572 took possession of the "smoke Grenades" for further inspection.

It should be noted, while searching/booking S/White we recovered makeshift riot gear such as shoulder pads, plastic tactical vest, gloves (EV-1), and a "Pyle" electronic bullhorn (EV-2). The suspects listed above, possessed items commonly used when intentionally causing a public disturbance to promote, participate in, or carry on a riot.

The above suspects possessed numerous items commonly used to to promote violence or inflict immediate damages and/or injury to property or any person.

The following items were also collected from the scene and packaged in plastic bags for evidence:

- -(1) "Speco Technologies" electronic bullhorn (EV-3).
- -(1) plastic bag containing miscellaneous flashlights and backpacks (EV-4).
- -(1) plastic bag containing miscellaneous helmets (EV-5).
- -(1) plastic bag containing miscellaneous protesting signs (EV-6) with the following messages, "Unforegivable & Unreformable Abolish The Police", "Police Can't Be Fixed", "PPD Pasadena, LASD Sheriffs, LAPD = Killers", "Who are you protecting and Serving", "No Justice No Peace Abolish Police".
- -(1) green cloth bag containing a gas mask (EV-7).
- -(1) Nikon D800 camera (EV-8).
- -(1) Nikon D5000 camera (EV-9).
- -(1) Diamondback Insight Bicycle (EV-10)
- -(1) black "Pharmacy" skateboard (EV-11).


It should be noted that bullhorns are electronic devices used for amplifying the sound of voice so it can be heard at a further distance. Gas mask are used to cover a persons face as a defense against inhaling airborne pollutants and toxic gases which are not commonly possessed during a peaceful protest unless there is a possible predicted attack from within the crowd.


Based on the above, suspects 1-17 were placed under arrest for failing to disperse at an unlawful assembly (violation of 409 PC).


Suspects 1-17 were transported and booked at South Los Angeles Station with the approval of Watch Commander Sergeant Meza #484495.



On 09-08-20, there was a scheduled protest at South Los Angeles Sheriff Station (1310 W Imperial Highway, Los Angeles, 90044) in regard to the recent death of "Dijon Kizzee." This protest was scheduled to start at 1600 hours and was advertised through many social media platforms (Instagram, Facebook, Twitter, Etc.) It should be noted, this protest followed a protest which took place on 09-07-20 which eventually was declared an unlawful assembly.

During the course of this protest, numerous protesters occupied Imperial Highway between Normandie Avenue and 108th Street, blocking traffic and creating a hostile and unsafe environment for the surrounding public. Protesters armed themselves with shields, shoulder pads, plastic body armor, helmets, and began throwing items towards Deputies.

At approximately 2010 hours, the Los Angeles County Sheriff Department Sergeant Muller #244802, declared the protest an unlawful assembly. Numerous dispersal orders were given to the protesters over a loud PA speaker to immediately disperse. Most of the protesters peacefully left the surrounding location. The following protestors failed to leave the immediate area and were subsequently arrested on 112th Street between Budlong Avenue and Normandie Avenue:
