1 **TO THE COURT, THE PARTIES, AND ALL COUNSEL OF RECORD:**

2 **PLEASE TAKE NOTICE** that on June 12, 2026 at 10:30 a.m. in Department C-68 of the
3 San Diego County Superior Court, located at 330 W. Broadway, San Diego, California, 92101,
4 before the Honorable Richard S. Whitney, Petitioner First Amendment Coalition will and hereby
5 does move for an order granting its Verified Petition for Declaratory Relief and Writ of Mandate
6 under the California Public Records Act (“Petition”).

7 Specifically, Petitioner moves the Court for:

8 1. A writ of mandate, order, and judgment in favor of Petitioner granting the Petition
9 and directing Respondent City of San Diego to disclose all records covered by Petitioner’s request
10 under the Public Records Act (“Request”), attached to the Petition as **Exhibit D** and the
11 Declaration of David Loy filed herewith as **Exhibit H**.

12 2. A judicial declaration that:

13 a. The records called for by the Request and withheld by Respondent fall
14 within Penal Code section 832.7, subdivisions (b)(1)(A)(i) and (b)(1)(A)(ii) and, as to
15 video and audio recordings, Government Code section 7923.625; and

16 b. Respondent violated the Public Records Act, (Gov. Code §§ 7920.000 et
17 seq.), Penal Code section 832.7, subdivision (b), and Article I, section 3(b) of the
18 California Constitution by denying the Request and withholding all records called for by
19 the Request in their entirety except a single redacted call log.

20 The records covered by the Request are subject to and not exempt from the presumption of
21 access enshrined in the Public Records Act, (Gov. Code, §§ 7920.000 et seq.), Penal Code section
22 832.7, subdivision (b), Government Code section 7923.625, and Article I, section 3(b) of the
23 California Constitution, and Respondent’s denial of Petitioner’s request and withholding of
24 requested records was and is inconsistent with these laws.

25 This Motion is based on this Notice, Petitioner’s Memorandum of Points and Authorities
26 in support of the Motion, the declaration of David Loy in support of the Motion, Petitioner’s
27 anticipated Reply in support of the Motion, all pleadings, records, and files in this action, and all

1 other evidence and argument that may be received by the Court before, at, or in connection with
2 the hearing on the Motion.
